

GDPR COMPLIANCE STATEMENT

IN RELATION TO THE MEETING OF THE BONDHOLDERS OF THE COMMON BOND LOAN OF AN AMOUNT OF €150,000,000 ISSUED BY THE COMPANY UNDER THE NAME "TERNA ENERGY FINANCE S.A. FINANCE"

ON 01.10.2024

"TERNA ENERGY FINANCE S.A." (hereinafter the "**Company**") notifies the Bondholders that in the context of their participation in the Bondholders' Meeting of the common bond loan of an amount of €150,000,000 (hereinafter the "**CBL**"), which the Company has issued by virtue of the CBL Programme for an amount up to €150,000,000, which will take place on **01.10.2024, Tuesday, at 15.00**, or in any Repetitive Meeting thereof (hereinafter the "**Meeting**"), the Bondholders' access codes to the Online Platform <https://axia.athexgroup.gr> (hereinafter the "**Online Platform**") ,through which they will be able to participate and vote remotely at the Meeting will be collected and processed by the data processor "Hellenic Central Securities Depository S.A.," which has been appointed by the Company to organize the Meeting.

The Company also informs the Bondholders that, according to paragraph 2 of Article 131 of Law 4548/2018, which applies accordingly, remote voting is open, and the exercise of the voting right by the Bondholder, along with the content of their vote, may be disclosed to the other participating Bondholders at the Meeting if so requested.

Additionally, the Company, as the data controller, informs, in accordance with Regulation (EU) 2016/679 of the European Parliament and the European Council (GDPR), the Law 4624/2019, and other provisions on the protection of personal data, the individuals other than Bondholders who will participate in the teleconference (video conference) of the Meeting, such as the Company's executives, Members of the Board of Directors, and executives of the Bondholders' Agent, and other third parties, that it processes the following data, which are collected directly by the subjects for the purposes of the legitimate interests pursued by the Company in relation to this processing:

- a) Identification data, such as full name, father's name, ID card number, or another equivalent document.
- b) Data related to the capacity under which these individuals are entitled to participate in the Meeting.
- c) Email address for the purpose of the individual's participation in the teleconference.
- d) Image - audio (video) data from the individual's participation in the Meeting.

Recipients of this data are the Company's executives responsible for managing the Meeting, the company under the name "Hellenic Central Securities Depository S.A.," which has been appointed by the Company as the data processor to organize the Meeting, and any sub-processors of the company "Hellenic Central Securities Depository S.A." (such as Zoom Video Communications Inc., which provides the Zoom meetings service for teleconferencing).

TERNA ENERGY FINANCE S.A.

In the context of and for the purposes for which the personal data are collected, they are retained by the Company for the period necessary under the applicable legal and regulatory framework, as well as for the exercise of claims or the protection of the Company's legitimate interests.

According to the GDPR, the data subjects have the following rights, which can be exercised, where appropriate:

- a) The right to know which personal data concerning them is held and processed by the Company, as well as its source (right of access).
- b) The right to request the rectification and/or completion of this data so that it is complete and accurate, by providing any necessary document demonstrating the need for rectification or completion (right to rectification).
- c) The right to request the restriction of the processing of their data (right to restriction).
- d) The right to object or oppose any further processing of their personal data held by the Company (right to object).
- e) The right to request the erasure of their data from the Company's records (right to be forgotten).
- f) The right to request the Company to transfer the data they have provided to any other data controller (right to data portability).

The Company will make every effort to respond to the individuals within thirty (30) days as of the date of the submission of their request, which may be extended by an additional sixty (60) days, if necessary, at the Company's discretion, considering the complexity of the request and the number of requests. The Company will inform the individual in any case of an extension of the thirty (30) day deadline within thirty (30) days as of the date of the receipt of their request and will also inform them about the reasons for the extension.

The Company implements an information security management system to ensure the confidentiality, security of data processing, and protection of personal data from accidental or unlawful destruction, loss, alteration, unauthorized disclosure, or access, and any other form of unlawful processing.

The individual has the right to file a complaint with the Hellenic Data Protection Authority (www.dpa.gr), which is the competent supervisory authority for the protection of the fundamental rights and freedoms of individuals with regard to their data processing, if they believe that their rights have been infringed in any way, as well as the right to judicial remedy.
